#### **SCHEDULE**

**Competition name** 'Riverton at AVJennings Pink Stumps Day VIP Ticket Giveaway 2022'

**Entry – residency restriction** Entry is available to Queensland residents only.

**Entry – age restriction** Must be over 18 years of age to enter.

**Competition Period** 7.00pm (AEST) on 07/02/2022 to Midday (AEST) 10/02/22

#### **How to enter**

1. Find the competition post on the Riverton by AVJennings Facebook page.
2. Comment "It's easy being PINK" and tag who you would like to take to the VIP area with you, in the comments section of the competition post by Midday (AEST) 10/02/22
3. Winner will be selected at random by AVJennings. Selection will take place with the winner to be decided and announced on or around 3pm AEST 10<sup>th</sup> February 2022. Winner will be contacted via Facebook Messenger. Winner be required to provide their name, their mobile phone number, a valid email address.
4. Winner must be available to attend the Jimboomba Cricket Club's Pink Stumps Day event on Saturday 12<sup>th</sup> February 2022 from 4pm, otherwise will forfeit the prize and a new winner will be drawn.

## **PART A - INTRODUCTION**

1. Information on how to enter and Prize details form part of these terms and conditions.
2. By participating in the Competition, entrants accept and agree to be bound by these terms and conditions. For the avoidance of doubt, the terms and conditions include the Schedule above.
3. Entries must comply with these terms and conditions to be valid.
4. Where there is an inconsistency between the Schedule and Parts A to J of these terms and conditions, the schedule will prevail.

## **PART B - PRIVACY**

5. The Promoter will collect and use each entrant's personal information including images, photographs, videos and other material for the purposes of:
  - a) conducting the Competition (which may include disclosure to third parties for the purpose of processing and conducting the Competition) and for promotional purposes, public statements, and advertisements in relation to the Competition; find
  - b) providing information about the products and services offered by the Promoter and its related companies and its affiliated retailers; and
  - c) research to improve its products and services.
6. By entering the Competition, each entrant consents to the use of their personal information and imagery of them as described in clause 5.

## **PART C - WHO CAN ENTER THE COMPETITION**

8. If the Schedule permits entrants to be under the age of 18 years, such entrants must seek permission from their parent or guardian to enter. If the winner of a Prize is under 18 years of age, the Prize will be awarded to the winner's parent or legal guardian.
9. Directors and employees (and their immediate family) of the Promoter or its related companies or agencies are not eligible to enter. Immediate family means spouse, ex-spouse, child, step-child, parent, step-parent, legal guardian, sibling or step-sibling.

## **PART D - HOW TO ENTER THE COMPETITION**

10. To enter, each entrant must comply with the 'How to Enter' section of the Schedule.
11. An entry cannot be modified after it has been submitted.
12. The Promoter reserves the right, at any time, to request verification of the age, identity, residential address or any other information relevant to participation in the Competition of all entrants. The Promoter reserves the right to disqualify any entrant who provides false information or fails to provide information that is reasonably requested by the Promoter.

13. The Promoter reserves the right, in its sole discretion, to refuse to accept entries which are incomplete, indecipherable, offensive, or otherwise unacceptable applying general community standards or do not comply with these terms and conditions or which contravene any applicable laws or regulations.
14. The Promoter reserves the right, in its sole discretion, to disqualify any entrant who has breached any of these terms and conditions, has engaged in unlawful or improper conduct or otherwise acts to cheat or undermine the fairness of the Competition by, for example, tampering with, or using or exploiting errors in, the entry process to obtain a competitive advantage over other entrants.
15. The eligibility of entries is solely within the discretion of the Promoter.
16. The Promoter accepts no responsibility for late, lost, misdirected or damaged entries or other communications.

#### **PART E - PRIZES**

17. Prize is not transferrable, exchangeable or redeemable for cash.
18. If a Prize is unavailable for reasons beyond the Promoter's control, the Promoter reserves the right to substitute the Prize with a prize of equal or greater monetary value. This right is subject to any applicable legislation, regulations or directions from a regulatory authority.
19. Once a Prize has left the Promoter's premises, the Promoter takes no responsibility for the Prize being damaged, lost or stolen. The Prize will be given to the representative, held out as such, of the winning household.
20. All taxes (excluding GST, if any) which may be payable as a consequence of receiving a Prize are the sole responsibility of each winner.
21. A winner's use of the Prize is entirely at their own risk. 24. The Judges' decision will be final and binding and no correspondence with entrants or any other person will be entered into.
25. The first nominated representative of the winning household will receive the Prize.

#### **PART G - NOTIFICATION AND CLAIMING THE PRIZE(S)**

26. The Promoter will provide the winner with instructions on how to claim and use their Prize. It is the responsibility of the winner to comply with the Promoter's instructions.
27. The Promoter reserves the right to request the winner to provide proof of their identity and/or proof that they were responsible for the winning entry.
28. Each winner agrees to participate and cooperate, as required, in all publicity activities relating to the Competition, including, without limitation, being interviewed, photographed, filmed and recorded. The winner authorises the Promoter to use such content and the entry imagery for advertising and publicity purposes in any media in perpetuity worldwide.

#### **PART H - UNCLAIMED PRIZES**

30. The Promoter will take all reasonable steps to identify and notify the winner in an attempt to ensure that the winner receives their Prize. #### **PART I – NO LIABILITY**

Each Prize may come with guarantees that cannot be excluded under the Australian Consumer Law. If those guarantees are not complied with, then you will have rights under the Australian Consumer Law. Subject to those guarantees and rights, the Promoter shall not be liable and excludes all liability (including negligence) for any loss or damage whatsoever which is suffered (including but not limited to indirect or consequential loss) for damage to property, personal injury or death suffered or sustained in connection with the Competition or the use or taking of any Prize except for any liability which cannot be excluded by law including as provided for under the Australian Consumer Law.
